This is a one-year, non-renewable scholarship. Scholarship funds are to be used for tuition and fees required to enroll full-time and attend an eligible educational institution in Florida in the 2026-2027 academic year. Scholarship funds may also be used for other direct course-related expenses—such as fees, books, supplies, and equipment—provided they are required of all students in the course of instruction. The scholarship cannot be used for transportation, housing, or dormitory costs.

To be eligible to apply for Suncoast Credit Union scholarship opportunity, students must meet the criteria listed below:

- Student must be a U.S. citizen, U.S. permanent resident, or an eligible non-citizen.
- Student must not be a director, employee, or family member of Directors or employees of Suncoast Credit Union, Members Title Company, Members Insurance Services, Members Trust Company or Suncoast Realty Solutions LLC.
- Student must enroll in an accredited Florida institution.
- Student must enroll in a 4-year college/university, 2-year college or technical school.
- Student must be currently attending a public high school, charter school or being home schooled in Collier County.
- Student must have an overall unweighted grade point average (GPA) of 2.5 or higher on a 4-point scale.
- Student must be a current high school senior (12th-grade student) that is college or technical school-bound.
- Qualify under at least ONE of the options outlined below:
  - Meet Free and Reduced Lunch program/ USDA Eligibility based on the 2024 Taxes with student listed as a dependent (blue column)
  - HUD Documentation from the US Department of HUD indicating that the family is receiving benefits AND 2024 Taxes with the student listed as a dependent (green column)
  - Student receives Medicaid from DCF or SSI
  - SNAP or TANF Recipient Documentation
